**RESOLUTION TO INCREASE THE TRANSPORT RATE FOR EMERGENCY  
VEHICLE TRANSPORTS**

**WHEREAS**, the Board of Fire Commissioners of North County Regional Fire Authority have reviewed the cost of operation for the emergency vehicle transport program; and

**WHEREAS**, the Board believes that it is unfair to charge the taxpayers of the Fire Authority generally for the extraordinary costs caused by a relatively few persons, and that such persons should, to the extent possible and reasonable, defray those costs; and

**WHEREAS**, the current emergency vehicle transport fee has not been adjusted since March 27, 2013; and

**WHEREAS**, the Board has determined that the emergency vehicle transport fee should be increased (effective January 1, 2016) to better meet the cost of operation'

**NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF FIRE  
COMMISSIONERS OF NORTH COUNTY REGIONAL FIRE AUTHORITY,  
SNOHOMISH COUNTY, STATE OF WASHINGTON, THAT:**

1. The charges for Basic Life Support transports shall be \$675
2. The charge for Advance Life Support transports shall be \$1050
3. The charge for advance Life Support 2 transports shall be \$1125
4. The mileage charge shall be \$19.00 per mile.
5. The non-transport charges pursuant to Resolution 10232013-01 will automatically be increased to match the Basic Life Support transport rate of \$675
