RESOLUTION NO. 12232015-02

AMENDING THE 2015 EXPENSE FUND OPERATING BUDGET

WHEREAS, the Board of Fire Commissioners (the "Board") of North County Regional Fire Authority (the "Authority) adopted at the regular meeting of the Board of Commissioners on December 10, 2014, an Expense Fund operating for the 2015 calendar year with a total anticipated resources of \$6,607,579 (including an unreserved beginning Expense Fund cash balance of \$745,000), and total estimated expenditures of \$5,858,719, plus a projected unreserved ending Expense Fund cash balance of \$748,860;

WHEREAS, during the 2015 calendar year, the Authority expects to expend additional resources to pay for previously unanticipated obligations, including, but not limited to: (I) retrofitting of two ambulances,(II) extraordinary level of litigious activity resulting in additional legal fees,(III), arbitration settlement costs, and, (IV) a large volume of expended overtime to cover open positions, and;

WHEREAS, the Authority has now projected that the actual expenditures for the 2015 calendar year will be \$6,696,102, and that the projected unreserved ending Expense Fund cash balance will be \$484,773.

WHEREAS, the Authority has also projected that the total anticipated resources available to the Authority during the 2015 calendar year will be sufficient to meet the total anticipated expenditures of \$6,696,102. Such anticipated resources available to the Authority during 2015 are projected to be \$6,993,894; and

WHEREAS, the Authority reasonable expects the total Unanticipated Expenses expended during the 2015 calendar year to be no more than eight hundred and thirty-seven thousand, and three hundred eight-three (\$837,383), and;

WHEREAS, the Board desires to amend the 2015 Budget to increase the total expense portion of the 2015 Budget to reflect the fact that the Authority's actual expenses during the 2015 calendar year exceeded the anticipated expenses set forth in the 2015 budget;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of North County Regional Fire Authority, as follows:

1. **2015** Expense Budget Amendment. The adopted 2015 expense budget is hereby amended to increase from the previously adopted amount of five million, eight hundred and fifty-eight thousand, and seven hundred nineteen dollars (\$5,858,719) to a revised total of six million, six hundred and ninety-six thousand and one hundred and two dollars (\$6,696,102).
